The Company has issued 1000 FCCBs, each valued at \$100,000, with the option to convert them into equity shares at a price to be determined at the time of conversion.  
Out of 1000 FCCB, 954 FCCB are yet outstanding as on the date.  
Therefore, in the declaration sheet, when asked whether the Company has issued any Convertible Securities, "YES" is selected. However, in the column for the number of outstanding convertible securities, "0" is indicated. This is because the conversion rate of FCCBs into equity shares will be established in the future, making it impossible to determine the exact number of equity shares to be converted as on the date of filing of shareholding pattern.
